### **Tour 1: St. Lawrence County Historical Association** (free)

Founded in 1947, the St. Lawrence County Historical Association (SLCHA) is headquartered in the Silas Wright House, which is listed on the National Register of Historic Places as part of the Canton Village Park Historic District. The Silas Wright House was built in 1832-33. In 1834, Senator Wright and his new bride Clarissa Moody Wright, purchased the house and over the next ten years, they enlarged it in the popular Greek Revival style in order to accommodate the Senator's important station in life. Silas Wright served as a US Senator from 1833-1844 and Governor of New York State from 1844-1846. The "Red Barn Addition" to the Silas Wright House was completed in 2001.

The SLCHA's museum features many exhibits including the mid-19<sup>th</sup> century period rooms of the Silas Wright House, The Shaping of St. Lawrence County, J. Henry Rushton: The Stradivarius of the Canoe, the Silas & Clarissa Wright Orientation exhibit, Frederic Remington: *The Way of an Indian*, and others. The Research Room contains various resources for local and family history research. Collections of note include Macomb Purchase Papers (original legal documents between Alexander Macomb and the State of New York for the purchase of the land which became St. Lawrence County); Silas Wright Collection, including personal and professional letters from the US Senator and NY Governor; J.H. Rushton Collection, including business materials of a renowned canoe and boat builder whose shop operated in Canton in the late 19<sup>th</sup> and early 20<sup>th</sup> century; the Walter B. Leonard Collection, including original

manuscripts, music, playbills, ephemera, photos, correspondence, and posters of this vaudevillian from Canton; and the Remington Collection of Richard G. Myers, including magazine illustrations, lifetime prints of Remington images sold by various publishers, early editions of the numerous books which Remington illustrated, as well as the many articles, short stories, and novels




which were both written and illustrated by Remington.

The tour will include the restricted archives and collections storage areas, in addition to the public areas. The drive to Canton from Potsdam is approximately 15 minutes and directions will be provided. For more information on the SLCHA, visit www.slcha.org.

### **Tour 2: Walking Tour of Historic Potsdam Buildings** (free)

Enjoy a leisurely walking tour of a number of historic buildings in downtown Potsdam. The tour will include several historic municipal buildings, architectural examples of several older homes, the historic downtown block, several churches, and the present Snell Hall now owned by Clarkson University, but formerly home of the Potsdam Normal School and Potsdam State Teachers College (predecessors of SUNY Potsdam). A highlight of the tour will be a stop on Fall Island in Potsdam, located between the two branches of the Racquette River in downtown Potsdam, where tour attendees will have the chance to see Trinity Episcopal Church, with its seven Tiffany stained glass windows, mostly dating between 1900 and 1920. ### **Tour 3: Printing Press Studio** (free)

Visit Mark McMurray's private printing press studio in Canton. Mark is Curator of Special Collections and University Archivist at St. Lawrence University. He has a second life as a press publisher, however, and he has designed, printed and published letterpress books and pamphlets under the trade name of Caliban Press, which he founded in 1985. Before his arrival at St. Lawrence University in 1993, he worked in the Special Collections Division at New York Public Library.

Mark owns several printing presses, including a 1947 Vandercook proof press, an 1830's Hoe Washington hand press, and a 1950's Chandler & Price Pilot Press. The visit will include viewing the studio and the printing presses, historical commentary about the printing presses, and commentary regarding how the printing presses are used in creating modern book arts publications.

This tour is limited to 14 people. If demand exceeds this number, everyone will be accommodated by providing a second session following the first session.

The drive to Canton from Potsdam is approximately 15 minutes and directions will be provided.

#### **Directions:**

Since most attendees will be arriving by car, those directions are given below:

[Note: parking permits are required for campus parking – you will be given an appropriate parking permit for either overnight parking if staying in the dorms, or commuter permit if not]

#### **BY CAR:**

From Interstate 81 (Western New York/Syracuse areas) Just north of Watertown from Interstate 81, take Exit 48 for Route 342 East. Travel approximately 6 miles east on Route 342 until the junction of Route 11. Turn left onto Route 11 North. Follow Route 11 North for approximately 64 miles until reaching the town of Potsdam. Once in the village, turn right onto 56 South. Route 56 turns into Pierrepont Avenue. For those not staying on-campus, from Pierrepont Avenue turn left onto Potsdam Drive (there is a maroon and white sign at the entrance to the college) and park in parking lot no. 2 (if construction still blocks part of Potsdam Drive, drive through parking lot no. 1 to get to parking lot no. 2). For those staying in on-campus accommodations, from Pierrepont Avenue turn left onto Barrington Drive, then turn right onto Massena Drive and park in parking lots 25 or 26.

From Interstate 87/The Northway (Albany and New York City areas) From all points south of Albany, travel I87 North/Thruway. Take Exit 24 through the tollbooth in Albany and continue north on 187/The Adirondack Northway for almost 60 miles. Take Exit 23 heading towards Route 9/Warrensburg. From exit ramp, turn left onto County Route 35 West. After approximately 3/10 of a mile, turn right onto Route 9 traveling northwest. Travel 4 miles until Route 28 North intersects with Route 9. Bear left at the fork onto Route 28 North. Follow Route 28 North for approximately 44 miles until Blue Mountain Lake. You will notice that Route 28 North and Route 30 North are the same road from Indian Lake to Blue Mountain Lake. Once in Blue Mountain Lake, you will turn right onto Route 30 North. After traveling about 34 miles, you will enter the town of Tupper Lake. It is here you will pick up Route 3 by turning left. Traveling mainly west, follow signs for Potsdam. Follow Route 3 for 12 miles. At Sevey's Corners turn right onto Route 56 North. Take Route 56 approximately 33 miles until the College comes into view on your right. For those staying in on-campus accommodations, from Pierrepont Avenue turn left onto Barrington Drive, then turn right onto Massena Drive and park in parking lots 25 or 26. For those not staying on-campus, from Pierrepont Avenue turn left onto Potsdam Drive (there is a maroon and white sign at the entrance to the college) and park in parking lot no. 2 (if construction still blocks part of Potsdam Drive, drive through parking lot no. 1 to get to parking lot no. 2).

**From Interstate 87/The Northway (Plattsburgh area)** Depending on your approach from I87, take Exit 37 or 38 to Route 374 West. Route 374 West will turn into Route 374 North. Follow Route 374 approximately 30 miles. Make a left onto County Route 24/Brainardsville Road in Brainardsville, NY.

Follow County Route 24/Brainardsville Road about 11.5 miles until it intersects Route 11 just east of Malone, NY. Turn left on Route 11 Southwest. Stay on Route 11 for 44 miles until your reach Potsdam. Once in the village, make a left onto Park Street, following signs for Route 56 South. Bear slightly left onto Route 56 South. Route 56 turns into Pierrepont Avenue. For those not staying on-campus, from Pierrepont Avenue turn left onto Potsdam Drive (there is a maroon and white sign at the entrance to the college) and park in parking lot no. 2 (if construction still blocks part of Potsdam Drive, drive through parking lot no. 1 to get to parking lot no. 2). For those staying in on-campus accommodations, from Pierrepont Avenue turn left onto Barrington Drive, then turn right onto Massena Drive and park in parking lots 25 or 26.

From Ottawa, Ontario, Canada Head west out of Ottawa on 417/The Queensway. From 417, take Highway 416 South towards Cardinal. You will be on 416 approximately 46 miles. Continue onto Highway 16 and then turn right onto Highway 2. Turn left off of Highway 2 to cross the international bridge. Once in New York, bear right onto Route 812 South. Route 812 and Route 37 are the same for a few miles. You will be on Route 812 about 4 miles. From 812, turn left on Route 68. Travel Route 68 for 17 miles until reaching Canton, NY. Here you will bear left onto Route 11. Follow Route 11 for 11 miles into Potsdam. Once in the village, turn right onto 56 South. Route 56 turns into Pierrepont Avenue. For those not staying on-campus, from Pierrepont Avenue turn left onto Potsdam Drive (there is a maroon and white sign at the entrance to the college) and park in parking lot no. 2 (if construction still blocks part of Potsdam Drive, drive through parking lot no. 1 to get to parking lot no. 2). For those staying in on-campus accommodations, from Pierrepont Avenue turn left onto Barrington Drive, then turn right onto Massena Drive and park in parking lots 25 or 26.
